toward sustainability. It was agreed upon that the e-waste collected from the College would be handed over to the Premier systems.

Preamble

Sadakathullah Appa College is engaged in providing quality education to students. The institution intends to dispose the e-waste such as desktops, servers, laptops, printers, keyboards, mouse etc. generated as per the Municipal Solid Waste (Management and Handling) Rules, 2000 under the guidance of the Central Pollution Board, Ministry of Environment and Forests.

Premier Systems has agreed to take charge of the said e-waste and collect, remove and dispose the same from the College located at Rahmath Nagar, Tirunelveli, in the manner prescribed by the concerned authorities on the following terms and conditions agreed to between the parties.

Scope of the Service

The College agrees to provide e-waste and the agency agrees to take charge of the disposed e-waste.

The College shall, at its sole discretion, send written intimation regarding the collection of e-waste to the Premier Systems either at a specified interval of time or whenever specified quantity of e-waste is generated. The said e-waste shall be collected from the College premises within 30 working days of intimation or any other period as required by the company. It will be the responsibility of the Premier Systems to collect the same from the premises and have the same transported from College to Premier Systems facility at its own costs & expenses in accordance with the guidelines and procedures prescribed by applicable authorities/laws and instructions of the College.

The parties hereby agree that the ownership and risk of loss of the said e-waste will transfer from College to Premier Systems upon delivery of the same to Premier systems in the College premises.

Terms and Conditions

This MOU is not a contractual or a financial obligation instrument. Nothing in this MOU shall obligate both the parties to enter into any contract or other obligation. Collaboration under this MOU shall be in accordance with applicable statutes and regulations. This MOU does not restrict both the parties from participating in similar activities or arrangements with other entities or agencies. Either Party may unilaterally withdraw at any time from this MOU by transmitting a signed written notice to that effect to the other Party.



SIM Agricultural Cattle Farm has agreed to take charge of the said food waste and collect, remove and dispose the same from the college located at Rahmath Nagar, Tirunelveli, following the guidelines prescribed by the concerned authorities on the following terms and conditions agreed to between the parties.

Scope of Service

The College agrees to provide food waste and the agency agrees to take charge of the disposed food waste.

The College shall, at its sole discretion, send written intimation to the SIM Agricultural Cattle Farm either at a specified interval of time or whenever specified quantity of food waste is generated. The said food waste shall be collected from the College premises every week by SIM Agricultural Cattle Farm after an intimation by the College or any other period as required by the company. It will be the responsibility of the SIM Agricultural Cattle Farm to collect the same from the premises and have the same transported from premises of the College to the SIM Agricultural Farm at its own costs & expenses in accordance with the guidelines and procedures prescribed by applicable authorities/laws and instructions of the College.




