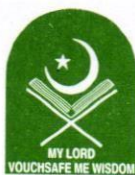

#### Solid Waste Management

The College focuses on processes and actions required to manage solid waste from its inception to its final disposal. This includes physical structures like incinerating and vermicomposting sites, technologies, economic mechanisms, disposal of waste and MoUs related to waste management processes. Dustbins are placed at every corridor, canteen and different locations on the campus. Under the supervision of the campus manager, sweepers are involved in collecting the waste generated on the campus. All waste/garbage collected by housekeeping personnel are segregated and incinerated weekly in the designated area away from the campus. Students and staff are educated on proper waste management practices through lectures, advertisement on notice boards, displaying slogan boards on the campus. The college also produces compost manure from the canteen solid waste and agricultural waste from the gardens. The two Ladies' Hostels have incinerators. There are two incineration pits on the campus, one next to the canteen and the other near the Girls canteen.

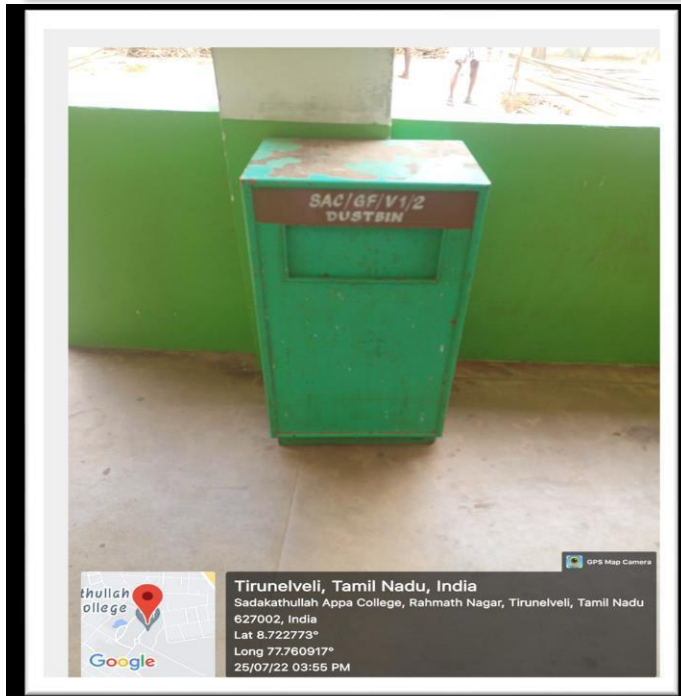

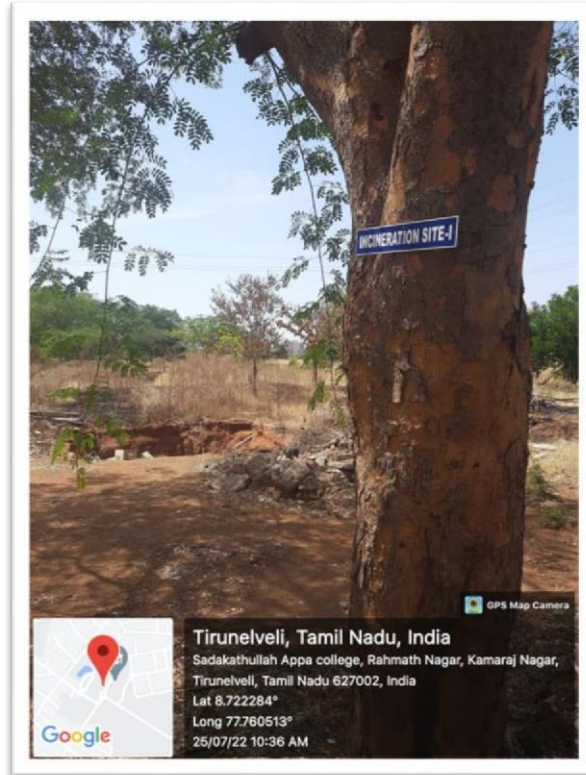

AGREEMENT FOR DISPOSAL OF FOOD WASTE

**Purpose**

Under this MoU, Sadakathullah Appa College and SIM Agricultural Cattle Farm will establish a beneficial link with a goal of disposal of Food waste. Sadakathullah Appa College has social responsibility to protect the environment and is committed to prevent pollution and improve efficient use of natural resources in compliance with all environmental regulations

**Effective Date and Administration**

This MoU will become effective upon signature by the Administrative Officer of Sadakathullah Appa College and SIM Agricultural Cattle Farm. It may be modified or amended by written agreement between the parties. This MoU will terminate at the end of five (5) years



and work toward sustainability. It was agreed upon that the Food waste collected from the College would be handed over to the SIM Agricultural Cattle Farm.

### **Preamble**

Sadakathullah Appa College is engaged in providing quality education to students. The Institution intends to dispose the food waste generated as per the Municipal Solid Waste Management Rules, 2016 and Solid Waste (Management and Handling) Rules, 2000 and guidance of the Central Pollution Board, Ministry of Environment, Forest and Climate Change.

SIM Agricultural Cattle Farm has agreed to take charge of the said food waste and collect, remove and dispose the same from the college located at Rahmath Nagar, Tirunelveli, following the guidelines prescribed by the concerned authorities on the following terms and conditions agreed to between the parties.

### **Scope of Service**

The College agrees to provide food waste and the agency agrees to take charge of the disposed food waste.

The College shall, at its sole discretion, send written intimation to the SIM Agricultural Cattle Farm either at a specified interval of time or whenever specified quantity of food waste is generated. The said food waste shall be collected from the College premises every week by SIM Agricultural Cattle Farm after an intimation by the College or any other period as required by the company. It will be the responsibility of the SIM Agricultural Cattle Farm to collect the same from the premises and have the same transported from premises of the College to the SIM Agricultural Farm at its own costs & expenses in accordance with the guidelines and procedures prescribed by applicable authorities/laws and instructions of the College.

### **Terms and Conditions**

This MoU is not a contractual or a financial obligation instrument. Nothing in this MoU shall obligate both the parties to enter into any contract or other obligation. Collaboration under this MoU shall be in accordance with applicable statutes and regulations. This MoU does not restrict both the parties from participating in similar activities or arrangements with other entities or agencies. Either Party may unilaterally withdraw at any time from this MoU by transmitting a signed written notice to that effect to the other Party.

### **Memorandum of Understanding (MoU) Commitments**

The Parties recognize the importance of collaboration to serve the needs of society. Consequently, the Parties are hereby establishing a working relationship and undertaking certain commitments with respect to environmental issues.

### **Effective Date and Administration**

This MoU will become effective upon signature by the Administrative Officer of Sadakathullah Appa College and SIM Agricultural Cattle Farm. It may be modified or amended by written agreement between the parties. This MoU will terminate at the end of five (5) years





