- ➤ Candidates shall submit the dissertation to the Research Centre through the Supervisor and Head of the Department within 6 months but not earlier than 5 months from the date of start of the second semester.
- The M.Phil. Scholars should attend at least one of the following training programmers ,Workshops, Seminars,Symposiums,etc .,and that they should also have a paper either published or received for acceptance in an ISSN/Reputed journal before Submitting the Dissertation . Scholars who fail to comply with the above or not eligible for the submission for their Dissertation .Photo copy of the publication /letter of acceptance for publication should be given as Annexure at the end of the Dissertation.
